**PRESENTATION OF TASK MAPPING**

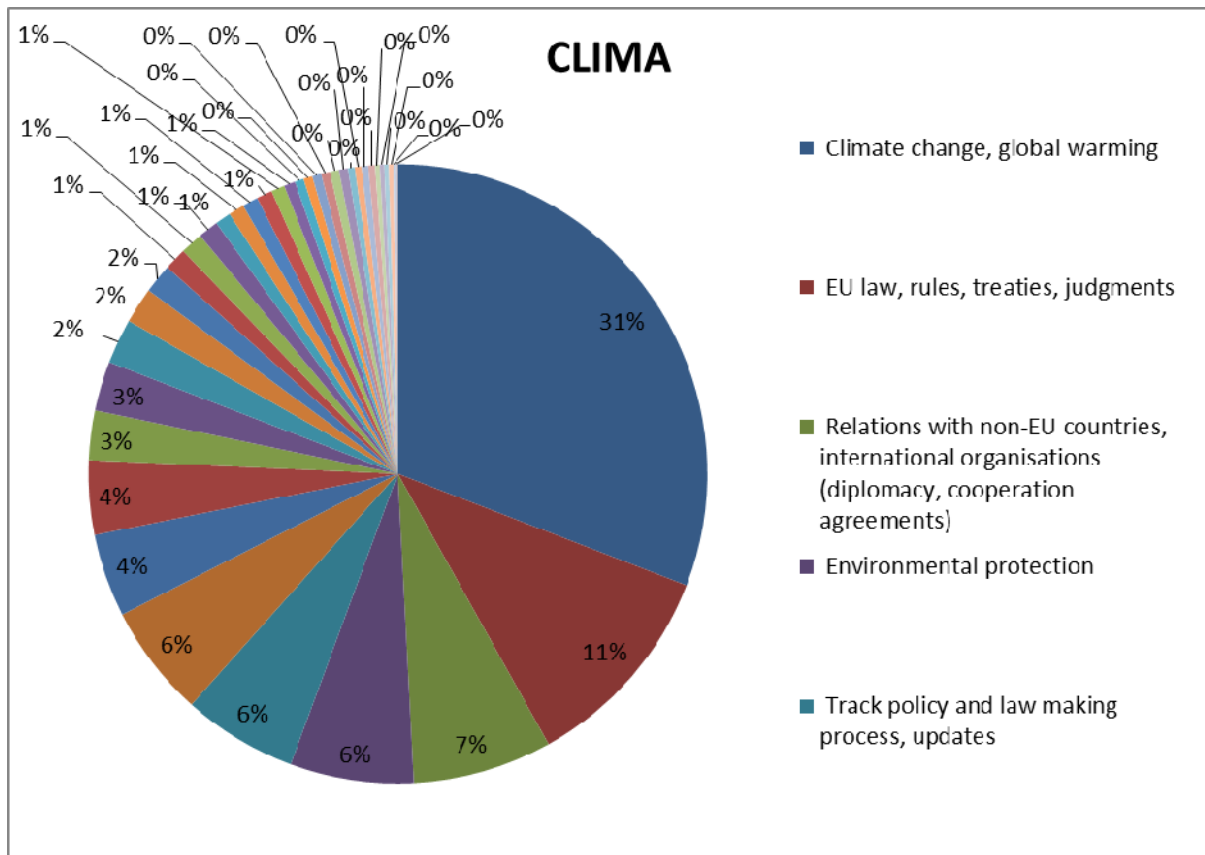
