Objective: Carry out pending changes derived from the amendment of Commission Regulation (EU) No 1089/2010.



- **Motivation**

Add 2 new items in the Protocol Value code list – Need for some missing codes to represent two types of resources:

- A web page with further instructions for accessing the dataset described through metadata.
- A direct access for downloading the dataset described through metadata.
