1. INSPIRE MIG MIWP Action 2016.5

The scope of this action 2016.5¹ under the "Working area 2: End user applications" of the Maintenance and Implementation Work Programme 2017-2020 has three main tasks:

- Task 1) provision of the agreed priority datasets for environmental reporting
- Task 2) Analysis "As Is"
- Task 3) Implementation

The Work programme 2017-2018 is focused on:

- Manage and update the priority list of eReporting datasets
- Make data available as-is: identify datasets, document metadata, make metadata and data available on the EU geoportal by providing network services
- Participate or track the development of the common and interoperable European data models per reporting obligation/data flow that are fit for purpose for the envisaged use case
- Monitoring the availability of pan-European datasets.

The members of the 2016.5 action met in the occasion of the INSPIRE Conference 2018.

2. Priority list of datasets for eReporting

The priority list of datasets for eReporting has been finalised as version 2.0. The priority list covers seven environmental domains, 22 EU environmental legal acts, 47 reporting obligations and identifies 96 different types of spatial data.

The priority list together with the corelated INSPIRE Priority datasets code list² are used to properly identify and describe the existing spatial datasets (provided "as is") that are available through the INSPIRE Geoportal. Such datasets were to be tagged in metadata with the dedicated keywords available in the INSPIRE registry. Further guidance is available from the priority dataset WIKI³.

3. Availability of the datasets for eReporting through the INSPIRE Geoportal

The overviews of downloadable spatial datasets that are recognised as datasets for eReporting are available from the INSPIRE Geoportal Priority Datasets Viewer by:

- Countries
- Environmental domains or
- Environmental legislation.

In addition to this pre-selection functionalities, the INSPIRE Geoportal includes the possibility to search in the Resource Browser on all metadata available through the discovery services.

3.1. Status and progress

The European Commission addressed the INSPIRE National Contact Points (NCPs) with a letter (Implementation of the INSPIRE Directive - follow up on the list of environmental priority datasets, ENV.E.4/JR/kpc) on 25 July 2018 to express their progress and action plans for the implementation of the datasets related to the priority list of dataset for eReporting. Several INSPIRE NCPs responded and a summary of their responses is presented in the following table:

3.2. Country overview of downloadable priority datasets

The comparison of the available downloadable priority datasets through the INSPIRE Geoportal shows a stable amount of metadata and a drop in download services (mainly triggered by a few Member States reorganising their data and thus reducing their amount of services) since June 2018. Since then, 7 Member States have started to provide metadata; 3 of them also download services.

The detailed overview shows that two groups of countries are lagging behind.

One group has not succeeded to provide neither metadata nor download services: Bulgaria, Greece, Hungary, Latvia, Liechtenstein, Lithuania, Poland, Switzerland and United Kingdom.

A second group has either not provided download services or the download services do not have a proper service–data linking and thus are not discoverable in the EU Geoportal: Croatia, France, Hungary, Ireland, Italy, Latvia and Sweden.

3.3. Overview of priority datasets by legislation

The overview of provided metadata for the priority datasets according to the EU environmental legislation shows that only for the latest Regulation 2017/852/EU (Mercury Regulation) both metadata and download services for the datasets are not yet available.

The majority of the data is provided based on the legislation on nature and biodiversity, water, air and noise. Looking from the perspective of legislation the number of countries (among 32 countries) that provide metadata for the spatial datasets is very diverse with a maximum of 20 countries that provide the metadata for the priority datasets related to the Directive 2000/60/EC – Water Framework Directive.




Figure 4: Number of Member Countries by legislation

3.4. Example: Priority datasets related to the Habitats and Birds Directives

The MIG had agreed to focus the initial provision of AS-IS data on nature and biodiversity related reporting – in particular data that is needed to describe the Natura 2000 situation. The downloadable priority datasets established according to the Directive 92/43/EEC (Habitats Directive) and Directive 209/147/EC (Birds Directive) are lised below.

In summary, 14 Member States have provided download services for the Habitats Directive and 12 for the Birds Directive. This is less than half of the Member States.

Technical recommendation: In providing this analysis, we discovered that further spatial datasets of Natura 2000 sites (part of datasets related to Habitats and Birds Directives) may be already available in the INSPIRE infrastructure but are not easily discoverable due to the quality of the applied metadata keywords from the INSPIRE Priority data set code list¹.

Therefore, we strongly recommend that:

- The most precise metadata keyword(s), indicating the content and purpose of the dataset, is applied, instead of more general keywords, e.g. legislation, and
- The identified priority datasets are indeed those that include authoritative data for the reporting obligation used in the reporting data flow.
