#### Latest release of the INSPIRE Validator

#### **Annual releases**

As mentioned above, several releases of the INSPIRE Reference Validator are scheduled each year with the main goal of concentrating breaking changes in the first half of the year in order to produce the major release used for the end-of-year Monitoring process already in June. The scheduled annual releases are described in detail in the next sub-sections. In addition to the different infrastructure and deployment environments, the different releases are managed using different branches of the *ets-repository* repository.

For simplicity, the descriptions make explicit reference to releases in the years 2020/2021, but the same release schedule will be applied consistently over the following years:

- v2020.1 15/03/2020: it includes both breaking and non-breaking changes.
- v2020.2 15/06/2020: it includes both breaking and non-breaking changes.
- v2020.3 15/09/2020: it only includes non-breaking changes, so that any INSPIRE resource passing the test in the previous release automatically passes the same test in this release. This release is the one used for the end-of-year Monitoring process.
- v2021.b 15/09/2020: it includes both breaking and non-breaking changes which are planned to become effective (for Monitoring purposes) in the following year.
   beta version NOT RELEASED
- v2021.0 15/01/2021: it includes both breaking and non-breaking changes, including those available in the beta instance of the previous year.



- v.2.1 to be released in December, will fix some INSPIRE-specific issues:
  - GML polygon orientation (caused by a deegree issue) [#60, #137, #147, #886]
  - invalid geometries (CRS issues) [<u>#203</u>, <u>#214</u>, <u>#267</u>, <u>#301</u>]

#### **INSPIRE Validator – Network of NCPs**

- Closed Action 2017.4 on Validation and conformity testing.
- Creation of a network of National Contact Points focused on validation
  - maintainers of national validators / experts in INSPIRE validation
  - main tasks:
    - staying up-to-date on the latest developments of the Validator
    - monitoring the issues raised in the Validator helpdesk and providing expert feedback
    - contributing to testing new developments of the Validator
    - promoting the use of the Validator at the national level and report on national efforts
    - advising on the long-term sustainability of the Validator
  - 21 experts from 14 countries: ES, CZ, SE, DE, BE, FI, NL, PT, SK, FR, HU, IT, AT, EL
  - kickoff meeting held on July 14
  - setup of a dedicated mailing list
