# **1.2.** Overview / list of selected good / highly visited / highly replied Forum contributions (your short description + link to the Forum content)

Since the restart of the INSPIRE Community Forum only a few number of discussion topics were added. 16 discussion topics have been added since June 2018. Most of them ask for clarification regarding the data specifications and data modelling. A number of questions point out the need for change in either the data specification (20) or the data model (47).

As change requests posted in 2015 to 2018 have not yet been resolved yet, the confidence in the change management is not given.

# **1.4.** Overview and assessment of the availability of thematic domain data sets in the EU Geoportal

The diagrams at the end of the document provide an overview of the current availability of metadata, download and view services for all themes in the thematic domain. Six of the seven themes belong to Annex I and datasets as well as services should have been made available by 23.11.2017. The number of missing resources requires an evaluation of technical and organisational issues at national and European level that prevent resources to be shown in the INSPIRE Geoportal.

The analysis of the INSPIRE Geoportal show a lack of datasets for different countries and different themes. There are no metadata, download nor view services for themes

- Addresses in Bulgaria, Greece, Hungary, Ireland, Malta
- Cadastral Parcels in Bulgaria, Switzerland

There are no metadata nor download nor view services for Greece for all themes beside Cadastral Parcels in the thematic domain.

The statistics for Ireland need to be double-checked as of 30.12.2020 only was only a few number of metadata available but not services. This is a significant drop down in comparison to the 2019 report (D1).




Figure 1. Overview of INSPIRE Services by Country for theme Addresses




Figure 2. Overview of INSPIRE Services by Country for theme Administrative Units




Figure 3. Overview of INSPIRE Services by Country for theme Cadastral Parcels




Figure 4. Overview of INSPIRE Services by Country for theme Geographical Names




Figure 5. Overview of INSPIRE Services by Country for theme Hydrography




Figure 6. Overview of INSPIRE Services by Country for theme Transport Network




Figure 7. Overview of INSPIRE Services by Country for theme Buildings
