### **ISSUES LOG BOOK**

## 1. OBJECTIVES AND BACKGROUND

Boosting international rail freight is a long-term objective endorsed by the Commission, Member States and the railway sector itself. To this end, the Programme Support Action (PSA) adopted by the Commission in April foresees the Issues Log Book as activity eligible for funding.
