# 1. Introduction

#### 1.1. VHR Image Acquisition for the CAP checks Programme

- 1.1.1. Since 1993, DG AGRI has promoted the use of "Controls with Remote Sensing" (CwRS) as an appropriate control system suitable to checking if aids are correctly granted. On the basis of the Council Regulation (EC) 165/94 (ref i) and of the Commission Regulation (EC) 601/94, the Commission Services are required to centralize the satellite images acquisition. This task was transferred to DG JRC in 1998 (September 1998/VI/34942). It is managed through a cross delegation (sub-delegation of signature) by DG AGRI to DG JRC.
- 1.1.2. Following the real time evaluation in 2003 and the successful operational application since 2004, DG JRC, in agreement with DG AGRI, continues to supply Very High Resolution (VHR) Satellite Remote Sensing (SRS) data, to the MS Administrations for their CwRS of area-based subsidies.
- 1.1.3. Since 2010, DG AGRI calls for a yearly LPIS Quality Assessment (LPIS QA). VHR Imagery acquired under the CwRS Campaign can be used for LPIS Quality Assessment providing that the zones satisfy the issued technical LPIS QA recommendations (see further Chapter 2.1.2 below)

#### 1.2. Objectives, referencing and structure of this document




Figure 1 - Figure showing structure of document and image acquisition process flow

- 1.2.1. This document constitutes the specifications for VHR imagery to be used within the CAP checks Programme (CwRS and LPIS QC). Its objective is to give the stakeholders¹ in the image acquisition process clarity in the technical details of the process and describes the process flow starting from zone definition, through the image use, reaching image return and possible re-use of imagery at end of Campaign (see Figure 1). - 1.2.2. Reference is made to the Common Technical Specifications (CTS) for the Remote Sensing Controls of area-based subsidies [ref ii]. Reference is also made to the WikiCAP website [ref iii, iv] for further recommendations. Reference is also made to the Guidelines for Best Practice and Quality Checking of Ortho Imagery (ref v).
- 1.2.3. Reference is also made to the HR Image Specifications for the CAP checks Programme [ref vi] which should be used in conjunction with present document.
- 1.2.4. Reference is also made to the terms and conditions of the satellite remote sensing (SRS) data Framework Contracts (FCs) for image procurement to the EC Services signed with Image Providers (IPs) [ref viii]

## 2. Zone Definition

#### 2.1. General

- 2.1.1. The regulatory basis for the CwRS programme is given in Article 20 of Council Regulation (EC) 73/2009 [ref. i] and article 33 to 35 of Commission Regulation (EC) 1122/2009, which allow Member States to use remote sensing techniques as a means of carrying out on the spot (OTS) checks on agricultural parcels. These are further described in the Common Technical Specifications for the Remote Sensing Controls of area-based subsidies [ref ii]. The WikiCAP website [ref iii, iv] on "selection of control zones" recommends that: "whether the control zones are selected on the basis of a risk analysis or at random, the technical constraints of satellite remote sensing sensors should be taken into account to optimize the probability of acquisition". These technical constraints, which are further detailed below, include: swath widths, elevation angles, Area Of Interest (AOI) definition, window adjustments, feasibility assessment, etc.
- 2.1.2. Article 6 (2) of above Commission Regulation (EC) 1122/2009, as modified by Commission regulation 146/2010, calls for a yearly LPIS QA. VHR Imagery acquired during the CwRS Campaign can be used for LPIS quality assessment providing that the zones satisfy the technical LPIS QA recommendations issued, including minimum elevation angle requirements [ref iv]. MS Administrations not participating in the CwRS programme can request specific acquisitions for LPIS assessment through the EC Services of the JRC.

#### 2.2. Zone parameters

2.2.1. A CAP Control zone (or AOI) consists of a minimum of 4 vertices in Lat/Long Geographic coordinates (decimal degrees, WGS 84 ellipsoid). It is represented by a shapefile containing all files with extensions .shp, .shx, .dbf, .sbx, .sbn, .prj and should be provided by the MS Administration, via EC Services, to the Image Provider. The MS Administration should strive to make shape files of simple, regular shapes and to avoid creating too narrow corridors (e.g. < 5 km width since IPs are not obliged to deliver bigger area to enable a smooth orthorectification of an image). The circles for autumn/winter windows will be used only when the MS Administration does not know the position of</p>

the VHR zones. VHR zones should fit within the circles. Zones shapes will be rejected by the EC Services if they: (1) overlap within the MS (only in exceptional cases (e.g. the control schemes/measures over the overlapping area are different and require separate windows like crops for vineyards) may this be allowed), (2) overlap adjoining MS borders (this includes Scotland/England/Wales), (3) cover large amounts of mountainous or other non-agricultural areas; (4) stretch into coastal waters. There is no regulatory limit to the number of vertices and no regulatory minimum distance between vertices of the shapefile. The minimum size of a zone is 100 km².

- 2.2.2. As imagery is acquired, depending on the sensor's technical characteristics, the zone is gradually covered entirely or strip-wise. The image provider, which is responsible for the implementation of an efficient image acquisition system, always aims to cover the zone in as few acquisitions as possible, but multi-temporal collection is valid if performed within the time limit of the acquisition window. Such multi-temporal acquisitions should be as close as possible in time since this favours crop interpretation, i.e. "multi-temporality" should be as short as possible.
- 2.2.3. All prime VHR zones are "dedicated zones". This has been judged to give the best programming and acquisition results. This means that for each zone the MS Administration has, after feasibility (see Chapter 4), accepted a dedicated single sensor or a dedicated sensor combination (Constellation Tasking) to be used to cover the zone.
- 2.2.4. Single sensor tasking each zone is allocated to one prime dedicated sensor:
  - GeoEye1 (GE1)
  - WorldView2 (WV2)
  - Quickbird2 (QB2)
  - Pleiades (PL1)[ref xvi]
- 2.2.5. Constellation Tasking each zone is allocated to one constellation:
  - GeoEye1 (GE1) with "enhanced" Ikonos (IK2)
  - WorldView2 (WV2) with Quickbird (QB2)
  - WorldView2 (WV2) with Quickbird (QB2) and WorldView (WV1)
  - WorldView2 (WV2) with WorldView1 (WV1)
- 2.2.6. Constellation GeoEye1 (GE1) with Ikonos (IK2) here the image provider will task both sensors in an optimal manner to acquire the zone as soon as possible with any of the two sensors. Multi sensor acquisition is accepted. The GE1 product specification has ≤ 10% CC and elevation angle 50-90° while the "enhanced" IK2 product has specification ≤ 5% CC, and elevation angle 67-90°.
- 2.2.7. Constellation WorldView2 (WV2) with Quickbird (QB2) here the image provider will task both sensors in an optimal manner to acquire the zone as soon as possible with either of the two sensors. Multi sensor acquisition is accepted. The WV2 and the QB2 products have the following specifications: ≤ 10% CC and elevation angle 50-90°.
- 2.2.8. Constellation WorldView2 (WV2) with Quickbird (QB2) and WorldView (WV1) here the Image Provider will task all three sensors in an 'optimal manner to acquire the zone as soon as possible with any of the three sensors. If a successful WV1 collection has been acquired, it will be uploaded into LIO as 'proposed'. As long as the contractor / JRC do not accept this image, Image Provider will continue in an 'optimal manner to programme the prime sensors WV2 and QB2 until the end of the window. If the contractor accepts the WV1 collection, all Acquisition Requests (ARs) for the relevant zone will be closed. If the window comes to an end without any WV2 or QB2 acquisitions (or partials only), the contractor is obliged to accept the WV1 collection (in case of partial for the remaining part). Multi sensor acquisition is accepted. The WV2, WV1 and the QB2 products specifications have; ≤ 10% CC and elevation angle 50-90°.

- 2.2.9. Constellation WorldView2 (WV2) and WorldView (WV1) here the Image Provider will task both sensors in an -optimal manner to acquire the zone as soon as possible with any of the two sensors. If a successful WV1 collection has been acquired, it will be uploaded into LIO as 'proposed'. As long as the contractor / JRC do not accept this image, Image Provider will continue in an -optimal manner to programme the prime sensor WV2 until the end of the window. If the contractor accepts the WV1 collection, all Acquisition Requests (ARs) for the relevant zone will be closed. If the window comes to an end without any WV2 acquisitions (or a partial one only), the contractor is obliged to accept the WV1 collection (in case of partial for the remaining part). Multisensor acquisition is accepted. The WV2, and WV1 products specifications have; ≤ 10% CC and elevation angle 50-90°.
- 2.2.10. The positive aspects of the above "constellation tasking" alternatives are that there will be an efficiency gained to complete the zone faster i.e. a reduction of the acquisition time by adding satellite capacity. Also, even though we will have the possibility of having a zone completed by > 1 sensor, there will be more chance that a 2nd acquisition is closer in time to the 1st acquisition i.e. less multi-temporality. This was demonstrated in the results of the campaign 2012.
- 2.2.11. When completing any zone, the necessary overlap (E-W or N-S) between subsequent acquisitions or strips should be a minimum of 0.5km. Also there shall be an overlap of a minimum of 0.5 km between any partial acquisitions between sensors acting in constellation. Such overlap is necessary for the orthorectification process.
- 2.2.12. Dedicated backup will not be used as of campaign 2012 onwards. A "speculative" backup may be performed by the "backup sensors" accepted by the MS Administration, chosen from WorldView 1, EROS B, SPOT Supermode (SPS panchromatic or COL), F2, THEOS, IK2 or QB2. Upon request from the MS Administrations and in especially critical circumstances speculative backup may also be performed by any prime sensor. However, when the dedicated prime sensor, or constellation of sensors, has fully acquired the zone any speculative backup window will be closed. Speculative backup will be purchased only if necessary (see item 3.1.7)
- 2.2.13. The VHR zone will, if completed by the prime dedicated sensor, be covered either by a bundle image (PAN and MSP as separate bands) or the pansharpened product or the PAN only (case of WV1 acting in constellation). In the case of WV2 the bundle image may contain 4 or 8 MSP bands depending on MS product choice.
- 2.2.14. All zone definition parameters should be defined by EC Services, in conjunction with MS Administrations, and given to Image Providers in the feasibility communication. From the 2012 CAP checks Campaign the MS Administrations will insert main zone parameters directly into LIODOTNET. Relevant zone definition parameters:
  - ✓ Member State
  - ✓ Zone name
  - ✓ Dedicated Sensor / Constellation
  - ✓ Speculative Backup Sensor
  - ✓ VHR window (from, to)
  - ✓ Product; bundle or pansharpened or PAN only
  - ✓ Requested Programming; default value: Priority Programming
  - ✓ Delivery; DVD or FTP
  - ✓ Shapefile; files with extensions .shp, .shx, .dbf, .sbx, .sbn, .prj (Lat/Long, WGS84)
  - ✓ Zone (AOI) area (rounded to whole km², UTM)
  - ✓ Maximum Cloud Cover (CC); default values: ≤10% GE1, WV2, PL1A, WV1, QB2, EROS B, SPOT Supermode (SPS/COL), F2 and THEOS; ≤5% IK2.

- ✓ Requested range of angle of elevation<sup>2</sup>; default values: 50-90° for GE1, WV2, PL1A, WV1, QB2; 57-90° for EROS B; 56-90° for SPOT5, 67-90° for IK2, F2
- ✓ An LPIS tagged zone automatically gets elevation angle uplift to 56-90° when using GE1, WV2, 63-90° when using QB2 and PL1A ³ (ref. iv)
- $\checkmark$  A zone tagged as mountainous gets elevation angle uplift to 67-90° for all sensors.

### 3. Acquisition Windows

- 3.1.1. There is normally one VHR image acquisition window defined for each CAP Control zone. This window will be defined by the MS Administrations and will be scheduled suitable for the measurement of the largest number of agricultural parcels possible. Exact dates will depend on crop cycle and will vary with Latitude. In specific cases a second VHR window may be allowed upon request and needs to be justified accordingly. Programming of a second window will depend on available budget.
- 3.1.2. The VHR prime window should be at least 6 but preferably 8 weeks long. If an HR-1 window is open it will close when the VHR prime window opens.
- 3.1.3. If extraordinary weather conditions prevail in any region, a window may change (opening and closing dates move). This will be dealt with on a case by case basis. Such acquisition window date changes should occur in very rare cases. If feasible, notice will be given by the contractor to the EC Services (who will contact the Image Provider) at the latest 2 weeks before scheduled opening.
- 3.1.4. An acquisition window may be extended if none of the prime or constellation tasking or speculative backup tasking has successfully acquired the zone. This will be dealt with on a case by case basis. Notice will be given by the contractor to EC Services (who will contact the Image Provider) at the latest 5 working days before window closure. This will allow the image provider to continue tasking. Such extensions will be made if crop cycle permits, or if the zone has only been partially covered.
- 3.1.5. It is not useful to open an acquisition window too early in the season as the sun angle is generally low and the crops may not have developed sufficiently to provide a scene with adequate contrast for a good delineation of the parcels. It is suggested not to open any window when sun angle is less than 20 deg. in order to ensure sufficient contrast and to minimize the effect of shadows.
- 3.1.6. If a VHR dedicated sensor acquires late in the window, upon request and if budget is available, the EC Services may request an archive search for an earlier HR sensor acquisition within the window.
- 3.1.7. If a window comes to an end with no acquisition or only a partial acquisition, the procedure outlined below will apply:
  - ✓ partial acquisition by dedicated prime or constellation sensor will be purchased (minimum deliverable area 100 km²)
  - ✓ area acquired by speculative backup will be purchased. Such speculative backup acquisition may
    be performed by any sensor requested by MS Administration on a zone. A speculative acquisition
    request will be open at the beginning of the window in accordance with a MS image request or IP
    warning on a potentially difficult zone. The EC Services may therefore open a speculative

acquisition request over a critical zone during the window even if not chosen by MS Administration from the beginning. If a sensor has completed a speculative backup acquisition, it will be purchased for the area not covered by the dedicated sensor/s at the end of the window. In addition to this complementary area, an overlap area of 0.5km will be purchased. If more than one speculative backup exists the contractor will normally decide which to use (EC Services have the final decision). Decision will depend on elevation angle, resolution and date.

- ✓ acquisitions outside elevation angle specification or outside Cloud Cover (CC) thresholds may be uploaded by the Image Providers as "proposed" and will be accepted if no other imagery is available to cover zone and if the contractor accepts. The price will be the Framework Contract (FC) pricing for a "proposed" acquisition.
- ✓ acquisitions outside the window (i.e. recent archive imagery) may be uploaded by the Image Providers (e.g. upon suggestion by contractors accessing Image Providers' on-line archives) at the end of the acquisition window. Such imagery will be chosen if no other imagery is available to cover zone and if the contractor accepts. The price will be the FC pricing for an archive acquisition.
- ✓ If none of the above options will provide enough images to complete the area, the acquisition window will be extended for the dedicated prime or constellation sensor and for the speculative backup. Each extension will last for 7 days. If within these 7 days no acquisition by the dedicated prime or constellation sensor is made, the speculative backup will be purchased. The MS will evaluate each week how many extensions are acceptable, based on the status of the cultures.
- 3.1.8. Upon request from the EC Services, the Image Providers will inform the EC Services of image acquisition status over the zone (e.g. attempts left before window closure, or possible attempt soon afterwards).

### 4. Feasibility

- 4.1.1. The image requests from the MS Administrations including zone definition parameters (see § 2.2.14) are received by the EC Services.
- 4.1.2. A technical and competitive feasibility by the Image Provider includes among other things; satellite characteristics, zone size, zone shape, zone latitude, elevation angle, acquisition window, priority level, CC, statistical weather forecasting and other competitive tasking requests. All tasking made by EC Services is placed at priority (or rush, or RED) programming.
- 4.1.3. The feasibility assessment, performed by the Image Provider, should divide the zones in 3 categories:
  - 1. FEASIBLE WITHIN WINDOW (\*) approaching 100% probability
  - 2. FEASIBLE WITHIN WINDOW (\*) 80% probability (may need EXTENSION)
  - 3. NOT FEASIBLE WITHIN WINDOW with suggestion to make feasible (extend window to..., allow elevation angle...)
  - (\*) +/- 3 days adjustment of window to fit satellite pass allowed
- 4.1.4. One of the parameters of the feasibility assessment is the elevation angle. It is well known that a lower elevation angle puts higher requirements on ancillary data (DEM, GCPs, etc.) to reach orthocorrection accuracy specification thresholds [ref v]. The elevation angle should be kept as high as possible by the Image Providers in order to facilitate

orthocorrection. In very few cases the MS Administrations may request a higher threshold than the ones allowed by these Technical Specifications (see § 2.2.14): one is if zone is used within the LPIS Quality Assessment, the second is if the control zone is situated in "hilly", or mountainous areas (with up to approx. 1000m topography change within control zone), and has complex topology.

- 4.1.5. Considering the cases above, the EC Services will allow 25% of the overall km² given to an Image Provider for feasibility to have an elevation angle restriction between 56°-90°. A maximum of 1/3 of this 25% may be between 67°-90° (i.e. remaining 2/3 between 56°-90°). These elevation angles fit with LPIS imagery restrictions since max. elevation angles are 56°(GE1, WV2) / 63°(QB2, PL1A) 90°. The topographically difficult zone will have the higher restriction 67°-90°. MS Administrations should bear in mind that they should keep within these % in their request for restriction.
- 4.1.6. The feasibility request from the EC services to the relevant image Providers will be made during January February of the month before the Campaign start.
- 4.1.7. The MS preferences for a specific sensor are considered as a first decision component for the feasibility, and the feasibility priority is to satisfy these MS requests. Those zones are passed to the relevant Image Provider with the request to perform a feasibility assessment.
- 4.1.8. If there are no or same preferences stated by the MS Administration the information is passed to all eligible Image Providers.
- 4.1.9. Upon return of the feasibility assessments, which should be no later than two weeks after EC Services request, the EC Services will perform a technical judgement with possible re-iterations: if a zone has feasibility class 1, 2 (see above item 4.1.3) it will be given to that Image Provider (class 2 might be re-iterated with the MS Administration to check if he prefers his second choice Image Provider), while if class 3 it will be re-iterated with the 2<sup>nd</sup> choice Image Provider.
- 4.1.10. Zones of same preference will be given to the provider which proves to give "best value for money".
- 4.1.11. Finally, an optimum acquisition scenario should be reached, and this result is communicated for acceptance by the MS Administrations.

# 5. Acquisition Request (AR)

- 5.1.1. After the feasibility assessment, dedicated programming is known; an Acquisition Request (AR) for the product is opened in LIODOTNET<sup>4</sup>. Each AR has a unique identifier called ARid.
- 5.1.2. Upon request from Image Provider, or from the EC Services a speculative AR may also be opened over the zone.
- 5.1.3. An Acquisition Request (AR) will close 2 working days after a window end.
- 5.1.4. LIODOTNET functionality is described in its manual available on line from LIODOTNET [ref xiv]. It is a WEB-based informatics application developed by the EC Services in order to manage Acquisition Request (AR), browse image upload, validation, ordering, delivery, invoicing and image return/archiving of satellite images. LIODOTNET is the main communication tool between the CAP checks actors<sup>5</sup> during the Campaign; its automatic email exchange can be used to synchronize actions between different actors. The web address is <a href="http://lio2.jrc.it/LioDotNet/Default.aspx">http://lio2.jrc.it/LioDotNet/Default.aspx</a>.

5.1.5. Preview of uploaded QuickLooks (QLs) is made using the CID QL Browser which is an online application for displaying and browsing QLs and shape files from the image acquisitions. It is reachable directly from within LIODOTNET (or externally at http://lio2.jrc.it/pub/lioglbrowser12/)

# 6. QL (Browse Image) Upload

- 6.1.1. Image Provider will "notify" the EC Services of an acquisition through an upload in the LIODOTNET system (or email in case of temporary system unavailability) within 2 working days of an acquisition (validated, proposed, or partial upload).
- 6.1.2. Uploading image acquisition details into the LIODOTNET starts by clicking on the proper AR (giving automatically some of the parameters: zone name, sensor, product, and acquisition type (dedicated, backup, or speculative)). Image details such as ARId, Country (ISO name), Zone Name, Product, Acquisition date (dd-mm-yyyy), CC (%), Haze Flag, Elevation angle, Display order (the display order of the given layer in the VHR Browser), Provider status (Validated, Proposed, not required), Filename etc. are defined in the XML file. The XML file with image QL, shapefile and other necessary files for georeferencing are zipped and uploaded.
- 6.1.3. Image Providers may also use an automatic upload of their image acquisition details. In this case email should be sent to a generic mailbox <a href="mailto:lio.net@jrc.ec.europa.eu">lio.net@jrc.ec.europa.eu</a> The automatic upload will generate the same Email notification as a normal upload. In automatic upload it is essential to specify the ARId in the XML: <ARId>21041</a>/ARId>5
- 6.1.4. Upon upload of dedicated or backup acquisition the LIODOTNET system will automatically send message to subscribed users. The other Image Providers are included in this message in order to avoid any unnecessary speculative backup tasking. User subscription in general is done through the LIODOTNET system, where also filters for which emails to receive may be applied.
- 6.1.5. A speculative backup is also introduced in LIODOTNET according to above procedure but will NOT be visible to contractors until the end of the window. To enable an efficient programming of sensors a speculative collection uploaded in LIODOTNET is visible to other relevant IPs for which a speculative AR is opened.
- 6.1.6. The Image Providers' own archives may be consulted by the contractors (services are normally free of charge and subject to subscription). Such archives include DigitalGlobe Browse Tool for QB, WV2 and WV1<sup>7</sup>, SPOTImage (DALI) for SPOT images, GeoEye's GeoFUSE<sup>8</sup> for IK2 and GE1, GEOSTORE of ASTRIUM for PL1A and SPOT family etc. Contractors may consult these archives and propose any imagery suitable for their controls activity to the EC Services; the EC Services will proceed, via the Image Providers, to upload QLs of such imagery into LIODOTNET for acceptance.

# 7. <u>Validation</u>

7.1.1. Validation may be performed over the whole zone or over a part of a zone (partial upload). It is always done on intersection of the "upload (or acquisition)" with the zone shapefile. The "upload (or acquisition)" has one date, is a contiguous area, and has a regular and simple shape. It is a strip/multiple strip for GE1, IK2, WV2, QB2, WV1, PL1A, EROS B, and is images for SPOT5 Supermode, and F2.

7.1.2. For a VHR zone the validation of an upload is done on the basis of CC content. Haze, which is not considered cloud by image provider, does not cause rejection but is flagged (see below § 7.1.99) and may trigger an extra re-tasking. The image provider uploads georeferenced QL and relevant XML file including CC assessment (following established CC threshold criteria) and haze assessment (haze flag) into LIODOTNET.

#### 7.1.3. VHR CC thresholds are defined as follows:

- ✓ A "validated" acquisition is defined by a maximum CC of ≤ 10% for GE1, WV2, PL1A, WV1, QB, EROS B, SPOT SPS, and F2; ≤ 5% for IK2. Validation of imagery is done within 2 working days by EC Services (no action in required by contractor). Validated images are delivered directly to contractor (after order has been received by image provider from the EC Services) having passed through Quality Control (QC) of the Image Provider (see Chapter X Delivery, and X Quality Assurance / Quality Control)
- ✓ A "proposed" acquisition is defined by a CC of > 10 ≤ 30% for GE1, WV2, PL1A, WV1, QB, EROS B, SPOT SPS, and F2; > 5% for IK2. Proposed images are delivered to the contractor only upon final agreement by EC Services. Programming continues for better acquisitions during the period of accept/decline which must not exceed 3 working days. The Commission notifies the image provider through LIODOTNET and thus gives instructions on future collection. After an "accept" the proposed scene goes through QC of the Image Provider and is shipped to the contractor (after order has been received by image provider from the EC Services).
- 7.1.4. Validation of a series of "proposed" acquisitions (uploads) the VHR Image Providers have agreed to provide "all" the "proposed" acquisitions to the contractor if the contractor accepts one "proposed" acquisition over his control zone. The contractor should therefore react within time limit on "proposed" acquisition (3 days), and reject if not usable; however keeping in mind that when further "proposed" acquisitions are made available over the same zone these can be used together with already rejected acquisitions by him.
- 7.1.5. In the case of constellation tasking (option Constellation including WV1 (see above Chapter 2.2.8, and 2.2.9), it should be noted that WV1 is uploaded as "proposed" and contractor may accept or let tasking of the prime WV2 with QB2, or prime WV2, continue until end of window.
- 7.1.6. The contractor and image provider should produce regular mosaics of "proposed" imagery to aid in decision on usability of such series of acquisitions. "Accept" of a series of "proposed" acquisitions will allow Image Providers to release satellite capacity for other zones.
- 7.1.7. Re-upload of a rejected acquisition image provider may re-upload part of a rejected "proposed" acquisition if it, in combination with, a new "validated" acquisition serves to complete a zone. The re-uploaded "proposed" acquisition has to be of "validated" CC threshold, of one date, be a contiguous area, and has to have a regular and simple shape.
- 7.1.8. In case of a conglomeration of CC within part of a large acquisition, this part (minimum 100km²) can be re-tasked, upon request of the EC Services, even if whole acquisition is "validated". A new AR will be issued for this part of the zone if contractor cannot use the portion of the validated acquisition covered by the CC conglomeration. Contractor will have to follow procedure similar to section below (Haze flag) in order to prove that the re-tasking is required by the EC Services. Decision will be taken by EC Services within 3 working days.

#### 7.1.9. VHR Haze flag is validated as follows:

- ✓ Validated CC upload with flag for dense haze the flag will trigger an e-mail to the Contractor who will assess if the dense haze prevents control of the parcels. This will be done within 3 working days by contractor who has to answer the EC Services on following issues in order for decision on possible re-tasking to be taken:
  - o prepare a shape file of the control parcel structure (lat/long DD WGS 84);

- assess preliminary T4 coding due haze (reference CTS [ref ii]);
- check if any proposed image is available;
- check if any backup images are available (EC Services will inform of any speculative images are available);
- o assess whether opening of an HR image may satisfy Computer Assisted Photo Interpretation (CAPI) needs and haze image is still acceptable for parcel measurement;
- assess whether the haze image can be used if an atmospheric correction sw is applied to imagery. It should be kept in mind that the image viewed is a QL, which is always inferior in quality compared to the real source image<sup>9</sup>.

If the above steps cannot ensure a successful control procedure:

- o prepare (possible) new shape file, if not complete zone, to re-collect (minimum 100km²);
- decide on a new window, and assess the time delay that a re-tasking implies for the success of your control procedure;

Upon reception of above information from the contractor the EC Services will take a decision to collect additional imagery (re-task) over part of the control zone based on technical and financial justification.

✓ Proposed CC upload with flag for dense haze - treated as proposed "acquisition"

# 8. Ordering

- 8.1.1. Normally an order is placed when the whole zone is fully covered, but a partially covered zone may be ordered at the MS contractor's request. This is to be considered exceptional, and will only be accepted if contractor is clearly suffering a time constraint. The area to be ordered is calculated (rounded to whole km²) as the intersection between georeferenced QLs of collection (using final ephemeris data) with the zone in geographic projection UTM/WGS 84.
- 8.1.2. Ordering of all imagery will be made using the EC Services' LIODOTNET system, and sent to the Image Provider in digital form. Order will contain all relevant acquisition details<sup>10</sup> including:
  - European Commission Joint Research Centre (JRC), Institute for Environment and Sustainability, IES, order #, Acquisition Request ID (ARid)
  - VHR: country, zone, period, state, area, acquisition date, elevation angle, product, CC, delivery media
  - delivery address
  - any other order parameters according to Chapter 12 Products.
- 8.1.3. Orders will be made in order letters containing as many zones as possible /one country /one contractor. Only in exceptional cases will an individual or partial zone be ordered.
- 8.1.4. To reduce the administration ordering of all dedicated imagery will be done at regular intervals (e.g. end of week) after acceptance of validated acquisition (complete or partial).
- 8.1.5. Ordering of speculative backup imagery, and any archive imagery, will be done after window closure.

8.1.6. All orders will be placed with commercial priority tasking (GE1, IK2, WV2, WV1, QB2, PL1A, F2), rush service (EROS B), and Red Programming (SPOT).

# 9. <u>Delivery</u>

- 9.1.1. Delivery will normally take place after completion of the whole zone. The product will thus contain imagery covering the whole zone, possibly of more than one date (many validated partial acquisitions), in the format and on the media asked for. If requested by the contractor, delivery of validated "proposed" imagery will include "all" proposed uploads over the zone.
- 9.1.2. Partial delivery may occur upon special request by a contractor, or when acquisition window has come to an end, or when image provider reports his tasking over the zone is finished. As a minimum (single partial delivery) the product will have one acquisition date, be of a minimum 100km² of contiguous area, and have a regular and simple shape.
- 9.1.3. The contractual delivery period (production, internal QC, and ex-works availability) agreed with the EC Services from the date of ordering are 6 working days for VHR data.
- 9.1.4. Images (after validation according to procedure in Chapter 7) are delivered directly to the contractor after having passed through the internal Quality Control (QC) of the Image Provider.
- 9.1.5. The contractor receives a "delivery note", through LIODOTNET, as soon as the product is shipped by the Image Provider. The delivery note includes order #, Acquisition Request ID (ARid), Acquisition ID (Aid). If product is delivered via FTP, the delivery note will contain also the FTP address, username and password (in some cases such information is also contained in the comments textbox of the upload itself).
- 9.1.6. If product is delivered on FTP, please bear in mind that FTP download of e.g. a 1.4 GByte scene at 1MBit/sec takes approx. 3½ hours. The contractor must download the product within 8 working days of the day placed on ftp server by image provider.
- 9.1.7. All Image Providers will not only deliver product to the contractor on DVD or FTP as requested, but will also deliver product to the EC Services on specific FTP account for automatic harvest (see Chapter 11 Image Return)
- 9.1.8. Introduction of checksum for correct delivery between Image provider and Contractor:

Virtually all image data for the CAP checks campaigns are now downloaded by JRC and contractors via FTP from the servers of the Image Providers. Due to possible service and connection interruptions the correct and complete download of files needs to be ensured. Currently this check can only be performed by running the full processing chain since no information about the individual files is supplied.

In order to enable contractors (and JRC) to check correct and complete download of image data from the FTP servers of the Image Providers, the JRC requests the following implementation of MD5 checksum files from the Image Providers:

The Image Providers shall create a separate MD5 checksum file for every data directory/subdirectory that contains data. This file shall be named "checksum.md5" and shall be placed together with the data files in the same directory. The creation of the checksum files shall be performed \*before\* placing the image data on the FTP server (during the copy of the large files data can get corrupted, but the MD5 checksums must be calculated for the correct data files).

The "checksum.md5" file shall have one line per file starting with the MD5 alphanumerical (\*not\* hexadecimal) checksum followed by exactly 2 blanks (or 1 blank and an asterisk) and then the file name. A sample structure would be eg.:

MD5 checksums can be read and created by all programming and scripting languages. So the creation of these checksum files can easily be integrated in any data preparation chain. Manual creation of the checksum files can easily be performed by using the command line tool md5sum (Unix/Mac) or md5sum.exe (MS Windows). The launch of this tool can also be put in simple scripts (like batch or shell scripts).

# Creation of the checksum.md5 files with md5sum:

Depending on CPU and the speed of file system, creating the md5 file for a directory with 15-20 GB data should take 2-3 minutes.

The checks can as well be integrated in download scripts to automatically check files after finished download.

The Windows executable can be downloaded e.g. here:

On Linux this is usually already installed.

- 9.1.9. The contractors will insert the actual date of receipt of ALL products linked to the single order in LIODOTNET (order page). LIODOTNET will remind contractor to fill in the image receipt once a day every working day after 6 days (contractual delivery time). The contractor will also fill in the Input Data Quality Assessment (IDQA) on the order page within 5 working days of reception and LIODOTNET will, also here, remind contractor to fill this in. These actions will allow
  - ✓ the EC Services to assess whether the observed delays comply with those agreed with the Image Providers
  - ✓ to trigger the invoicing procedure

✓ assess initial quality of delivered imagery

If there is a delay in the nomination of the contractor then the MS Administration must perform all contractor actions.

9.1.10. Upon request from the EC Services, the Image Provider will inform on Image production/QC status (production pending, production finished, production date)

## 10. Invoicing

#### 10.1. Pricing

10.1.1. Pricing for products will be according to Framework Contracts (FC) stipulated with the Image Providers [ref vii], or amendments thereto.

#### 10.2. Invoicing

- 10.2.1. As soon as image dispatch has been made by the image provider, they will send a "draft" invoice to the EC Services.

  They will "tick" the draft invoice "sent" box in LIODOTNET (order page). Each "draft" invoice will be checked by the Financial Unit of the EC Services within 5 working days of reception.
- 10.2.2. In previous Campaigns a "final" invoice could be sent by the Image Provider to the EC Services only after the IDQA is was filled in by the contractor or MS Administration (see § 9.1.9 above). LIODOTNET will notify Image Provider when IDQA is filled in by contractor so Image Provider may issue final invoice. From 2013 Campaign if the IDQA is not filled in by the contractor or MS Administration in the established 7 working days from dispatch of the imagery, the Image Provider may send the final invoice to the EC Services. The order page in Lio.Net will be updated later."
- 10.2.3. If IDQA is not satisfactory and therefore fails (or issue is waiting to be solved) there is the possibility for the Image Provider to make partial invoicing of the orders that have been accepted and IDQA:ed positively.
- 10.2.4. Final Invoices are to be sent to the EC Services at the following address:

10.2.5. The Financial Unit of the EC Services will proceed with payment if imagery is collected according to given specifications and invoicing by image provider follows the procedures described above. The EC Services' payment terms as defined in FCs is calculated from date of reception of final invoice in the CAD Office of the JRC, Ispra.

# 11. Image Data Return and Image Access

#### 11.1. Image Data Return

- 11.1.1. Since the 2009 campaign all source imagery supplied to the EC Services has been harvested automatically by the EC Services. For this purpose each Image Provider will provide the EC services with access to either an FTP account with a "Country / Zone\_name / Image\_1" directory structure under it, or to one FTP account per country with a "Zone\_name / Image\_1" directory structure under each of them. The Image Provider should provide such account independent of delivery media to contractors.
- 11.1.2. The VHR ortho-corrected imagery used in the CAP checks Campaign must be returned to the EC Services at JRC, Ispra no later than 01.12.2013. The delivery should include the data and the necessary documentation:

- ✓ metadata describing content of CD/DVD will be introduced in LIODOTNET under the menu "Image Returns"; one image return # will be given for each PERIOD (VHR), and PROCESSING LEVEL (ortho).
- ✓ also, a specific XML metadata file needs to be compiled and provided. Please read carefully the instructions and use the online form at:

http://cidportal.jrc.ec.europa.eu/public-tools/image-return/metadata/

Fill in the required information, then create and save the XML file. Place this XML file together with your orthoimage file keeping the naming convention "\*\_meta.xml" as mentioned in the online instructions. All images will be stored on the CID portal server and will be available to the MS Administrations under specific conditions (see Chapter on Image Access below).

11.1.3. For the VHR images, for every single image received by the contractor, all bands that have been orthorectified shall be returned in GeoTIFF or Erdas IMAGINE (HFA) format. If an uncompressed (possibly pansharpened) mosaic of the zone is available, this can be returned instead or in addition to the single images. For mosaics of the full control zone it is not required to provide the "\*\_meta.xml" file as mentioned above for every single mosaic tile. In this case it is sufficient to provide the required information in a single file named "mosaic\_meta.xml". It is absolutely mandatory to specify the coordinate reference system (CRS) associated to every single product as an EPSG code (<a href="http://www.epsg.org/Geodetic.html">http://www.epsg.org/Geodetic.html</a>). In case an EPSG code does not exist for the CRS used in the product, the CRS specifications shall be provided in Well Known Text format (description in the OpenGIS Project document 01-009 available at <a href="http://www.opengeospatial.org/docs/01-009.pdf">http://www.opengeospatial.org/docs/01-009.pdf</a>).

#### 11.2. Image Access

- 11.2.1. MS Administrations may access imagery purchased by the EC Services. This image access needs to follow principles set up in the Licensing Agreement between the Supplier (Image Provider) and the EC Services, in the respective Framework Contract [ref. vii). A specific EULA (End User License Agreement) following these principles will be presented to the user upon data access at CIDportal Registration [ref viii].
- 11.2.2. Images used in above operations may neither be disseminated nor the resulting products sold. Image access and return should be arranged through the CID server of the EC Services, Ispra.
- 11.2.3. The EC Service purchases a limited right to the use of the images, but the images themselves remain the property of the Image Providers.

The End User of the imagery provided must abide the provisions of the End User Licence Agreement (EULA), which is compliant with the Licensing Terms and Conditions agreed upon by the JRC and the Supplier. In accordance with the EULA (Ref. viii, Chapter 6 on IPRs) imagery must have proper references. When using the imagery the Licensee needs to refer to the supplier with the exact display of the credits as specified in the product's metadata e.g.:

"© owner or supplier name or mission name (year of acquisition, or validity of Framework Contract), all rights reserved)". In addition, the End User should indicate the following information: "data received via the Joint Research Centre of the European Commission".

#### 12. Sensors and Products

#### 12.1. GeoEye-1 (GE1) prime (or constellation with IK2)

12.1.1. The GE1 system is built to acquire large areas in a single pass (up to 100x100 Km or 300x50 Km), anyway the best efficiency (meaning the capacity to acquire as many zones per pass as possible) is achieved with zones up to 40x40 Km.

- 12.1.2. At launch the GE1 system could acquire forwards and backwards (bi-directional scan) giving a very high collection rate. Today it acquires only in one scan direction but is still capable of acquiring at a sufficient rate (thanks also to the recently introduced Enhanced Line Rate scanning mode, which allows to scan at 20,000 lps also for colour acquisitions), and can still acquire large zones in one orbit path. The satellite is designed to work in a preferred East-West scanning direction (but it works also North-South), therefore it is especially recommended for zones having an E-W orientation.
- 12.1.3. Due to its very high resolution and high geo-location accuracy, this satellite is especially recommended for zones where CAPI of specific crops could benefit from the higher resolution of both the panchromatic and multispectral data, or where there is a need to get very high ortho accuracies and there are not many (or good) GCPs.
- 12.1.4. For benchmark tests see [ref. ix]
- 12.1.5. For GE1 the products ordered will be /km2:
  - Geo products (which include RPCs)
  - Bundle (Panchromatic and 4 Multispectral bands as a single 4-layers file), or Pansharpened (4 multispectral bands at PAN resolution, provided as a single 4-layers file); on request Multispectral and Pansharpened products can also be produced as 4 separate files; Pansharpened orders will be acquired using the ELR (Enhanced Line Rate), while Bundle orders will be acquired as SLR (Standard Line Rate)
  - Bundle (Panchromatic and 4 multispectral bands as 4 separate files or as a single 4-layers file), or Pansharpened (4 multispectral bands at PAN resolution, provided as 4 separate files or as a single 4-layers file)
  - Resolution at nadir 0.41m PAN (resampled to 0.5m), 1.65m MSP (resampled to 2.0m)
  - Swath width at nadir is 15.2km
  - Elevation angle 50-90°
  - Cloud cover "validated"  $0 \le 10\%$ , "proposed"  $> 10 \le 30\%$  CC
  - Resampling CC
  - Format GeoTIFF
  - DRA (dynamic range adjustment) off
  - bit depth 16 bit (image 11bit)
  - UTM Datum WGS84
  - Commercial Priority Tasking
  - DVD delivery or FTP delivery
  - Until specific module is provided for GE1 by sw vendors the EC services have reached very good orthocorrection results using:
    - ✓ PCI 10.1 Geomatica OrthoEngine (RPC IK2 model, degree 1 polynomial)
    - ✓ ERDAS LPS 9.2. (RPC IK2 model, degree 1 polynomial)
  - GE1 maximum component size 4GB

#### 12.2. WorldView2 (WV2) prime (or constellation with QB2 or QB2/WV1 or WV1)

- 12.2.1. The WV2 system is built to acquire large areas typically more than 100x100 km in a single pass, as well as multiple single shot (point) targets. However, an efficient collection scheme is achieved with zones of approx. 40x40 km which will provide a moderate to high area yield per pass. Due to the extreme agility of the satellite another efficient collection scenario is multiple single shots of 15x15 km. A mix of both scenarios is also acceptable.
- 12.2.2. W2 acquires in forward and backward (bi-directional) scan. Together with the very fast slewing and the wide image swath of 16.4 km at nadir this leads to a very high collection rate. The satellite can scan in north-south, east-west or any other arbitrary direction (scan azimuth) in between. Because of the extreme agility of the satellite the individual orientation of each AOI is of less importance. However, in the interests of the overall project a consistent AOI orientation will be more auspicious, either a combination of a) more or less square zones plus north-south oriented zones, or b) square zones plus east-west oriented zones. Option a) is slightly preferable.
- 12.2.3. WV2 features a very high resolution, high geolocation accuracy, 8 multispectral bands and extreme agility. Therefore it is especially recommended for the following cases: a) zones where CAPI of specific crops benefits from the high spatial resolution of both the panchromatic and multispectral data, b) zones that need very high ortho accuracies, c) applications that may benefit from the increased spectral resolution, and d) areas with high density of control zones (AOIs) or exceptionally large control zones that benefit from the satellite's collection capacity due to its agility.
- 12.2.4. For benchmark tests see [ref. x]
- 12.2.5. For WV2 the products ordered will be /km2
  - Ortho Ready Standard Bundle 4 bands (PAN plus 4 Bands MS (BGRNIR1)
  - Ortho Ready Standard Pansharpened 4 Bands (BGRNIR)
  - Ortho Ready Standard Bundle 8 bands (PAN plus 4 Bands MS (BGRNIR1) plus 4 Bands MS2 (Coastal, Yellow, RedEdge, NIR2)
  - Resolution 0.46m PAN (resampled to 0.5m), 1.84m MSP (resampled to 2.0m)
  - Swath width at nadir 16.4 km
  - Elevation angle 50-90°
  - Cloud cover "validated"  $0 \le 10\%$ , "proposed"  $> 10 \le 30\%$  CC
  - Resampling Cubic convolution
  - Format GeoTIFF
  - DRA (dynamic range adjustment) off
  - bit depth 16 bit (image 11bit)

#### 12.3. Pleiades prime (PL1)

- 12.3.1. Pléiades is composed of two twin satellites (PL1A, and PL1B<sup>11</sup>) operated as a real constellation: on the same orbit and phased 180° one from the other. This orbit phasing allows the satellites to revisit any point on the globe daily.
- 12.3.2. The Pleiades system can acquire large areas strip mapping over large areas, typically up to 5 contiguous strips of 150 km each in a single pass, as well as multiple single shot (point) targets. Due to the extreme agility of the satellite another efficient collection scenario is multiple single acquisitions of 20x20 km during the same pass, typically 20 images within a country of 1000x1000 km. A mix of both scenarios can be used as well.
- 12.3.3. Pleiades acquires in forward and backward (bi-directional) scan. Together with the very fast slewing and the wide image swath of 20 km at nadir this leads to a very high collection rate. The satellite can scan in north-south, east-west or any other arbitrary direction (scan azimuth) in between.
- 12.3.4. For benchmark tests on PL1A see [ref. xv, xvi]
- 12.3.5. For Pleiades (PL1A) the products ordered will be /km²
  - Primary Product (equivalent 1A level of processing): Bundle 4 bands (Panchromatic Band and the 4 Multispectral Bands (B,G,R,NIR)
  - Primary Product:Pan-sharpened 4 Bands (B,G,R,NIR)
  - Resolution: 0.50m Panchromatic and 2.00m Multispectral from GSD of 0.70m, 2.80m respectively
  - Elevation angle: 50-90°
  - Cloud cover: "validated"  $0 \le 10\%$ , "proposed"  $> 10 \le 30\%$  CC
  - Resampling: Shannon Sampling (Spline kernel), deconvolution/denoising/zooming
  - Image format: GeoTIFF or JPEG 2000
  - File format DIMAP V2
  - Linear Adjustment optional on/off or tailored to need
  - Bit depth: 8 or 12 bits for JPEG 2000, 8 or 16 bits for GeoTIFF
  - Compression rate (for IPEG 2000 only): Optimised or Regular (= lossless)
  - Tasking service: Standard, Priority
  - DVD (4.7 GB max), FTP or Hard Drive (500 GB) delivery
  - Swath width at nadir: 20 km
  - UTM Datum WGS84
  - Image tiling: Products exceeding a certain size limit are broken up into smaller pieces called "tiles" constituting the whole product. Each tile can be opened separately.

If a product is not tiled, the filename is: 'product\_R1C1.JP2' (Row 1, Column 1)

If a product is tiled, there are as many image files as tiles, named 'Product\_RiCi.JP2'.

All other metadata (RPC XML and DIM XML) are not tiled and are applicable to the whole product

Tile size limit is approximately:

- 2 GB file size for GeoTIFF products
- Max. 4 GB file size for JPEG 2000

In the future, this limit could change as software capabilities progress.

The tile size is constant, meaning all tiles have the same volume (Mb/Gb), with a possible exception of the tiles in the last rows and columns, as black fill pixels are not included to fill the constant size.

- The tiles of the first row begin at the upper and left borders of the bounding rectangle of the AOI
- The tiles of the last row and column are trimmed to the bottom and right borders of the bounding rectangle of the AOI
- Tiles are not overlapping
- 12.3.6. The preferred software suites (with relative versions) for orthocorrection are: standard Commercial Off-The-Shelf PCI Geomatica 2013, ERDAS 2011 (release 2011.0.5) and ENVI 5 (Service Pack 1, version classic), and Astrium inhouse Pixel Factory 4 (Patch 6).

## The Quickbird (QB2) prime (or constellation with WV2 or WV2/WV1) / speculative backup

- 12.3.7. The satellite tasking optimisation may be reached by ordering single areas of 14km width with variable length (approx. 20-90km). Up to two strips over one target can be acquired on specific near-nadir passes, but more than 1 strip usually requires multiple passes. The most efficient scenario is N-S aligned strips, although the satellite is capable of acquiring also diagonally, or horizontally, when necessary or more optimal in some cases.
- 12.3.8. Due to the very high resolution of the QB sensor there will be a tendency to assign this satellite sensor to zones with small parcel sizes, or where CAPI of specific crops could benefit from the higher resolution of both the panchromatic and multispectral data.
- 12.3.9. For QB2 the products ordered will be /km2:
  - Standard Ortho-Ready (or Standard 2A)<sup>12</sup>, Basic format (1B)<sup>13</sup>
  - Bundle (Panchromatic and 4 multispectral separate bands; 2 files), or Pansharpened (4 multispectral bands at PAN resolution; 1 file)
  - Resolution PAN 0.6 / MSP 2.4m
  - Off-nadir angle 0-37° (elevation angle 50-90°), (see Annex for conversion between the two angles)
  - Cloud cover "validated"  $0 \le 10\%$ , "proposed"  $> 10 \le 30\%$  CC
  - Resampling Cubic Convolution
  - Format GeoTIFF 1.0
  - bit depth 16 bit (image 11bit)
  - UTM Datum WGS84
  - Special Priority Tasking
  - DVD delivery or FTP delivery
  - Image tiling:
    - ✓ 4 Band Bundle (32k x 32k tiling): MUL files have a max of 537 MB/tile, PAN files have a max of 2,140 GB /tile (\*) under implementation if not ready will be 16kx16k)

<sup>12.</sup> A Standard Image is radiometrically calibrated, corrected for sensor and platform-induced distortions and mapped to a cartographic projection. More in detail the radiometric corrections applied to the Standard product include: relative radiometric response between detectors, non-responsive detector fill, and a conversion for absolute radiometry. The sensor corrections account for internal detector geometry, optical distortion, scan distortion, any line-rate variations, and incorrect registration of the multi-spectral bands. Geometric corrections remove spacecraft orbit position and attitude uncertainty, earth rotation and curvature, and panoramic distortion. Additionally, a coarse DEM is used to normalize for topographic relief with respect to the referenced ellipsoid. The degree of normalization is relatively small, so while this product has terrain corrections, it is not considered orthorectified. The Ortho-Ready Standard product (OR Standard 2A) is also available, without use of the mentioned coarse DEM, which allows ortho-rectification with accuracies comparable to those obtained from Basic Imagery. EC Services are obtaining very good orthorectification accuracies with this Std Ortho Ready format (OR Standard 2A) using the Rational Polynomial Coefficients (RPCs), and adequate ancillary data (GCPs, DEM) both for QB, and in initial tests of WV1.

Basic format (1B) is delivered only upon request since the Std Ortho Ready format (2A) with Rational Polynomial Coefficients (RPCs) is giving very good results<sup>4</sup>. Basic imagery is the least processed image product; only corrections for radiometric distortions and adjustments for internal sensor geometry, optical and sensor distortions have been performed. This imagery is more difficult to handle, it has pixel size depending on off-nadir view angle, requires reference data of higher quality, and more GCPs to orthocorrect. The format however includes orbital parameters (ATT and EPH) updated every 0,02 seconds of an acquisition scan and allows more accurate modelling of the acquisition. In the specific case a sw suite requires the Basic format for orthocorrection this format may be delivered by the EC Services.

• With the delivered QB products there is the folder named GIS\_FILES with detailed shape files of the different tiles provided, which gives an overview of the product structure.

# 12.4. The Ikonos2 "enhanced" (IK2) (constellation with GE1) / speculative backup

- 12.4.1. The most efficient IK zone, for the purposes of a large set of CAP Control zones, is a 30x30 km² square acquired in one pass consisting of 3 strips of 10km width (technically the IK2 sensor may acquire also larger areas in one acquisition; 20x40km, 20x60km, 40x60km).
- 12.4.2. The IK2 system can acquire forwards and backwards giving a high collection rate, which means that there will be a tendency to acquire larger zones with this satellite sensor.
- 12.4.3. For IK2 the products ordered will be /km<sup>2</sup>:
  - Geo products (which include RPCs)
  - Bundle (Panchromatic and 4 Multispectral bands as a single 4-layers file), or Pansharpened (4 multispectral bands at PAN resolution, provided as a single 4-layers file); on request Multispectral and Pansharpened products can also be produced as 4 separate files
  - Resolution at nadir 0.82m PAN (products can be provided at full resolution or resampled to 1m),
     3.28m MSP (products can be provided at full resolution or resampled to 4m)
  - Swath width at nadir is 11.3 km
  - Elevation angle 67-90° (i.e. off-nadir angle 0-36° for IK), (see Annex for conversion between the two angles)
  - Cloud cover "validated"  $0 \le 5$  %, "proposed"  $> 5 \le 30$  % CC
  - Resampling Cubic convolution
  - Format GeoTIFF 1.0
  - DRA (dynamic range adjustment) off
  - bit depth 16 bit (image 11bit)
  - UTM Datum WGS84
  - •
  - Commercial Priority Tasking
  - DVD delivery or FTP delivery
  - IK2 maximum component size 4GB

#### 12.5. The WorldView1 (WV1) (constellation with WV2 or WV2/QB2) / speculative backup

12.5.1. WV1 acquires in forward and backward (bi-directional) scan. Together with the very fast slewing and the wide image swath of 17.6 km at nadir this leads to a very high collection rate. The satellite can scan in north-south, east-west or any other arbitrary direction (scan azimuth) in between. Because of the extreme agility of the satellite the individual orientation of each AOI is of less importance. However, in the interests of the overall project a consistent AOI orientation will be more auspicious, either a combination of a) more or less square zones plus north-south oriented zones, or b) square zones plus east-west oriented zones. Option a) is slightly preferable.

- 12.5.2. WV1 features a very high resolution, high geolocation accuracy, and extreme agility. Therefore it is especially recommended for the following cases: a) zones where CAPI of specific crops benefits from the high spatial resolution of the panchromatic data, b) zones that need very high ortho accuracies, and c) areas with high density of control zones (AOIs) that benefit from the satellite's collection capacity due to its agility.
- 12.5.3. The quality and efficiency of the WV1 data has been assessed by the EC Services (ref xi)
- 12.5.4. WV1 data will normally be used as a speculative backup at the Administration's request and most often in difficult climatic zones (e.g. above 45 ° Lat.), or of zones which present difficulties in the feasibility assessment.
- 12.5.5. For WV1 the products ordered will be /km<sup>2</sup>:
  - Standard Ortho-Ready (OR Standard 2A), Basic format (1B)
  - the data is panchromatic (PAN)
  - Resolution 0.50m
  - Off-nadir angle 0-37°, (elevation angle 50-90°), (see Annex for conversion between the two angles)
  - Cloud cover "validated"  $0 \le 10\%$ , "proposed"  $> 10 \le 30\%$  CC
  - Resampling Cubic Convolution
  - Format GeoTIFF 1.0
  - bit depth 16 bit (image 11bit)
  - UTM Datum WGS84
  - Special Priority Tasking
  - DVD delivery or FTP delivery
  - recommended minimum versions of software suites that can ortho correct WV1 data are e.g. ERDAS Imagine 9.2 (Basic format using rigorous modelling, Std Ortho-Ready format using QB RPC model), ERDAS Imagine 9.1 (std ortho ready format using QB RPC model), PCI 10.1.2., Keystone SIPOrtho.
  - Tiling:
    - ✓ Image tiling 32k x 32k tiling: PAN files have a max of 2,140 GB /tile

#### 12.6. The EROS B speculative backup

- 12.6.1. The swath width of the EROS B satellite is 7km, but a mosaic of multiples of this can be acquired in the same path.

  The most efficient EROS B zone is 26kmx28km.
- 12.6.2. EROS B data only exists as PAN.
- 12.6.3. Such data will normally be used as a speculative backup at the Administration's request and most often in difficult climatic zones (e.g. above 45° Lat.), or for zones which present difficulties in the feasibility assessment.
- 12.6.4. MS Administrations need to ensure that their contractors can handle EROS B data orthocorrection otherwise such backup will not be programmed by the EC Services.
- 12.6.5. Zones programmed with EROS B will be imaged starting half a second earlier and finishing half a second later in order to ensure correct telemetry at start/end of scene, this will allow usage of GCPs close to the boarder of the zones (a problem which was noted in 2008 Campaign)
- 12.6.6. The quality and efficiency of the EROS B data has been assessed by the EC Services (ref xi).
- 12.6.7. For EROS B the products ordered will be /km²:
  - EROS B level 1A (plus pass file); panchromatic
  - Resolution 0.7m.
  - Swath width at nadir is 7km
  - Maximum off-nadir view angle 30° (i.e. 57-90° elevation angle), (see Annex for conversion between the two angles)
  - Cloud cover "validated"  $0 \le 10\%$ , "proposed"  $> 10 \le 30\%$  CC
  - Format tiff (1A)
  - Bit depth 16 bit (image 11 bit)
  - UTM Datum WGS84
  - Commercial Rush Service
  - DVD delivery or FTP delivery
  - SW recommended Socet Set (EROS B model), ERDAS Imagine 9.2 and PCI Geomatica 10.1.1.

#### 12.7. The SPOT5 Supermode (SPS/COL) speculative backup

- 12.7.1. For SPOT5 "Supermode", the zone may be a full scene (60x60km) or where possible ½ scene (40x40km), ¼ scene (30x30km), 1/8 scene (20x20km). The EC Services will provide the size of scene fitting the CAP Control zone.
- 12.7.2. The SPOT5 HRG sensor, with its "Supermode" 2.5m resolution imagery (resulting from interleaving, interpolation, restoration of 2 simultaneous HRG 5m PAN images) will be programmed as a speculative backup at MS Administrations' request and most often in difficult climatic zones (e.g. above 45° Lat.), or of zones which present difficulties in the feasibility assessment. It will be used where the mean parcel size of the claimed area allows the use of such resolution, with relevant buffer tolerance [ref ii and iii]. The MS Administrations keep the responsibility of allowing usage of this type of data.
- 12.7.3. Acquisition of SPOT5 with its "Supermode" 2.5m and SPOT 5 MSP (10m) is possible contemporarily in order to obtain the requested MSP component over the zone for the VHR window. This may be performed in order to

produce SPOT 2.5m COL (which however reduces SPOT 5 HRG instruments' chances of looking elsewhere since one of the HRG instruments must acquire three images simultaneously).

- 12.7.4. For SPOT 5 Supermode (SPS/COL) the products ordered will be:
  - full scene 60x60km, ½ scene 40x40km, ¼ scene 30x30km, or 1/8 scene 20x20km
  - SPOT5 Supermode; BW, 1A
  - upon request SPOT5 COL5m, COL 2.5m
  - Off-nadir view angle 0-30° (56-90° elevation angle)
  - Cloud cover "validated" 0 ≤10%, "proposed" > 10 ≤ 30% CC
  - Resampling Cubic convolution
  - Format GeoTIFF 1.0
  - File format DIMAP
  - bit depth 16 bit (image 11bit)
  - UTM Datum WGS84
  - Blue / Red Programming Service
  - DVD delivery or FTP delivery

#### 12.8. The Formosat2 (F2) speculative backup

- 12.8.1. The most efficient F2 zone will be a single scene 24x24 km or a longer N-S strip of 24 km width. The nature of the satellite being geo- and sun- synchronous permits a daily revisit time of locations on earth which can be reached from its orbit.
- 12.8.2. F2 bundle data (PAN plus 4 MSP bands) or pansharpened (upon request) of 2m respectively 8m GSD at nadir will be used as a speculative backup at MS Administrations' request and most often in difficult climatic zones (e.g. above 45° Lat.), or of zones which present difficulties in the feasibility assessment.
- 12.8.3. The quality and efficiency of the F2 data has been evaluated by the EC Services [ref. xii]. RMSE<sub>1D</sub> and have been set conservatively to 5m which may be revised downward after further assessment. Restrictions have also been set on the across/along angles to 20/25 deg. These restrictions on off-nadir view angles, not only ensure reaching required location accuracy, but are also consistent with GSD as a function of satellite viewing angles. GSD remains below 2.5m if mentioned restrictions on angles are maintained, and F2 may therefore be considered similar to SPOT Supermode as far as the panchromatic image content is concerned.




Figure 2 - F2: GSD at, at nadir is 2m PAN, and 8m MSP Internal ref: JRC IES/H06/C/PAR/par

- 12.8.4. For F2 data the product order will be /scene:
  - Processing level Radiometrically corrected level 1A with basic radiometric normalisation for detectors calibration, but with no geometric correction.
  - Swath width at nadir is 24km
  - Resolution is 2m PAN, 8m MSP
  - Product options: PAN, and pansharp
  - DIMAP format (image in GeoTIFF, and metadata in XML file METADATA.DIM); F2 is delivered with filtered ephemeris and attitude data, refined focal plane calibration.
  - Elevation angles 67-90° (across), and 61-90° (along) (i.e. across 0-20°, along 0-25°); (see Annex for conversion between off-nadir and elevation angle)
  - Cloud cover "validated"  $0 \le 10\%$ , "proposed"  $> 10 \le 30\%$  CC
  - 8 bits/pixel
  - priority tasking
  - recommended minimum versions of sw suites are PCI Geomatica 10 with fix 10031, Erdas Imagine
     9.1 with fix 33599, Erdas IMAGINE 9.2, Keystone SIPOrtho, Prodigeo of EADS SPOTImage and
     Socet Set.

#### 12.9. The THEOS speculative backup

- 12.9.1. THEOS is an Earth observation mission of Thailand, developed at EADS Astrium SAS, Toulouse, France. GISTDA (Geo-Informatics and Space Technology Development Agency) of Bangkok is the owner of the satellite and is Thailand"s leading national organization in the field of space activities and applications. The Thai Ministry of Science and Technology is funding the programme. The EC Services have signed a FC with the Swedish Space Corporation (SSC) for the procurement of imagery (FC 386.601)
- 12.9.2. The THEOS System allows 2 different missions: panchromatic, high resolution with rather small field of view (FOV) and multispectral, medium resolution with large FOV
  - Panchromatic, or pansharpened
    - o Class of QB2 to F2 (10 to 20 km swath)
    - o To be used in CAP checks VHR speculative backup scenario (GSD 2m PAN and 15m MSP)
  - Multispectral
    - o Class of SPOT, Landsat, IRS (>60 km swath)
    - o To be used in CAP checks HR 1st come 1st served scenario (GSD 22m PAN and 90m MSP)
- 12.9.3. THEOS will be programmed as a speculative backup, if requested by MS Administrations. Such backup will be speculative; on zones declared as "difficult" at feasibility; or on zones declared as "critical" towards end of window.
- 12.9.4. The quality and efficiency of the THEOS data has been assessed by the EC Services [ref xiii].
- 12.9.5. For THEOS data the product order will be /scene.
  - Level 1A radiometrically corrected [product annotations provide information about the image localization (see THEOS User Guide, 2009)].

- Level 2A geometrically corrected of systematic effects, e.g., panoramic effect, earth curvature and
  rotation, in addition to radiometric correction. The imagery is projected to a standard cartographic
  projection (UTM WGS84 by default) using a terrain model without ground control points. (THEOS
  User Guide, 2009). Requires systematic error elimination.
- Level 3 Orthorectified by Spacemetric Keystone
- Resolution: 2 m (PAN) and 15m (MS) at nadir
- Scene based PAN 22x22km, pansharp 22x22km
- Product options: PAN, and pansharp
- Off-nadir view angles 65-90° (i.e. off-nadir 0-22°); (see Annex for conversion between off-nadir and elevation angle)
- SW suites for orthocorrection: ERDAS Imagine and LPS 10.3 version and PCI Geomatics 10.3.0 version supports only the rigorous THEOS sensor model that requires 1A level of processing image (THEOS RPC still to be implemented)
- Other SW suites for orthocorrection: Spacemetric Keystone that requires 1A level of processing image
- SW suites under development: Pixel Factory, ENVI and Keystone

# 13. Quality Assurance / Quality Control

#### 13.1. Image Quality Control (QC)

- 13.1.1. Quality Assurance (QA) may be defined to be the steps performed in order to ensure that the production of a product meets a set of accepted standards. Quality Control (QC) aims to detect non-conformities in a product.
- 13.1.2. QC includes assessment of issues such as data integrity, completeness, CC, haze or thin clouds, fog, smoke, smog, snow, flares and possibly cloud shadows, etc. It will proceed on the image product where geometry, radiometry, image characteristics (dropouts etc.), production parameters (resampling algorithm, bit depth), etc. are evaluated.
- 13.1.3. The Image Providers will follow their internally-defined QC procedures including at least the above issues. They will deliver a conformal product (or propose a non-conformal product for evaluation clearly stating reasons for QC failure such image will be treated as a "proposed" image). Such image can also be e.g. an acquisition at elevation angle below requirement.
- 13.1.4. The contractor receiving the product needs to report on any non-conformity within 5 days of reception of imagery, through the update of IDQA information in LIODOTNET.

#### 13.2. Cloud Cover (CC)

- 13.2.1. Cloud will be defined as white opaque with little or no image information available of the ground features below.

  Dense haze which causes consistent muting of imagery should be included.
- 13.2.2. IP have different CC assessment routines<sup>14</sup>;

- 1. Automatic or semi-automatic thresholding, with subsequent quality factor including issues of dense haze, haze, smoke, pollution, snow, shadow, etc. A visual observation after classification is required to adjust CC taking into account issues of dense haze, cloud conglomeration, etc.
- 2. Manual photo interpretation and subsequent vector digitizing; if a definite boundary between affected pixels and un-affected pixels is visible it is cloud.
- 13.2.3. It has been decided by the EC Services that a common CC assessment approach by all Image Providers does not solve CAP checks assessment problems. The Image Providers' routines are used commercially world-wide and are difficult to homogenize, but the CC is interpreted rather similarly by the methods used. Among the contractors there are varying opinions.
- 13.2.4. Both of above approaches are therefore accepted by the EC Services who insist on the need to manage the CAP checks programme efficiently (limited budget) and to guarantee success of the programme. They also insist on the need to have clear decision rules, common definitions and to optimise the use of acquired imagery. These issues should be considered by all actors<sup>1</sup> in the CAP checks programme for common benefit.
- 13.2.5. CC validation and haze flagging should therefore follow the procedure described in Chapter 7 Validation.
- 13.2.6. The accuracy to which CC will be performed is to a better than 1% definition.

# 14. Risk of Satellite Failure

14.1.1. The Image Providers are responsible for communicating any technical problem connected to a satellite system, to the receiving station or to the processing chain as soon as possible to the EC Services. This is important in order to limit risks to the Campaign by allowing switching to other satellite systems or switching to traditional on-the-spot checks for the control of the area-based subsidies.


