3. Manage My Submissions

3.1 View and Manage Submission

The My Submission(s) section of the Funding & Tenders Portal is dedicated to the management of your tender submissions through eSubmission for:

- · Open Procedures in direct management, or
- Restricted Procedures (steps 1 and 2) in direct management, or
- Negotiated Procedures (first and subsequent rounds on invitation) in direct management, or
- Requests for Specific Contracts (under Framework Contracts SIEA 2018, AUDIT 2018, PSF 2019, EVA 2020, EVENTS 2020, and EOM 2021).

3.1.1 New Submission

You can start your submission for:

- Open Procedures with submit a tender from the published call, and then New Submission on the eSubmission > Tender Data page of the
 portal (see below and Find and Participate in a Call);
- Restricted Procedures step 1 with submit a request to participate from the published call, and then New Submission on the eSubmission > T ender Data page of the portal (see below and Find and Participate in a Call);
- Restricted Procedures step 2 or Negotiated Procedures first and subsequent rounds, following your invitation, by selecting the "Create Tender" option from the Action button of the invitation on the portal, or New Submission on the eSubmission page of the portal (accessible via the link in the invitation e-mail/notification received) (see below and Manage My Invitations).

3.2 Submission Deadline

Once you have started a **new submission**, remember to submit it <u>before</u> the submission deadline. The submission deadline is clearly indicated either as a **deadline time and date**, or as a **countdown reminder**, in the details of the invitation and new submission.





The **submission deadline** is calculated from when the <u>Contracting Authority sends the invitations/requests</u>, and vary between public procurement procedures and Framework Contracts.

The submission deadline is always at 14H00 (CET) on the submission deadline date. If invitations are sent out after 14H00 (CET), the submission deadline date will include +1 day, so that the required minimum days for submission are always respected.

In the table below are examples of submission deadlines for Requests for Specific Contracts under Framework Contracts:

Framework Contract	Submission Deadline
SIEA 2018	 14 calendar days for a maximum budgeted amount below 300,000 EUR; or 30 calendar days for a maximum budgeted amount of 300,000 EUR and above.
AUDIT 2018	For a Request for Specific Contract under the Framework Contract AUDIT 2018 , the deadline for submission is min. 21 calendar days , but can be increased or decreased. If decreased, <u>an agreement is required</u> from the tenderers after the sending of the Request for Specific Contract.
PSF 2019	 14 calendar days for a maximum budgeted amount below 300,000 EUR; or 30 calendar days for a maximum budgeted amount of 300,000 EUR and above. For a Request for Specific Contract under the Framework Contract PSF 2019, and for duly justified exceptional cases subject to pre-approval by the Director of Service for Foreign Policy Instruments, the deadline for the submission of the offers can be halved to 7 or 15 calendar days respectively, and depending on the maximum budgeted amount.
EVA 2020	For a Request for Specific Contract under the Framework Contract EVA 2020, the deadline for submission is min. 21 calendar days, but can be increased or decreased. If decreased, an agreement is required from the Contractors after the sending of the Request for Specific Contract.
EVENTS 2020	 14 calendar days for a maximum budgeted amount below 300,000 EUR; or 30 calendar days for a maximum budgeted amount of 300,000 EUR and above.
EOM 2021	For a Request for Specific Contract under the Framework Contract EOM 2021 , the allocated time for the <i>submission of the offers</i> is min. 14 calendar days , but can be increased or decreased. Only in exceptional and duly justified cases can the Request for Services have a shorter period of submission of offers, but under <u>no circumstances can this deadline be shorter than 7 calendar days</u> .

3.3 Tender Procedure

Following a new submission (or resuming a draft submission), you will be automatically redirected to the eSubmission > Tender Procedure page of the submission.

Leven though there may be common steps in the procedure, the instructions below are specific to contracting procedures for Specific Contracts under Framework Contracts SIEA 2018, AUDIT 2018, PSF 2019, EVA 2020 and EVENTS 2020.

3.3.1 Tender Procedure - Steps

The eSubmission tender procedure is divided into multiple steps to facilitate the submission of the offers/tenders by Economic Operators. Not all steps are required, as it will depend on the type of procedure for public procurement, or the Framework Contract for Requests for Specific Contracts.

Preparation

- Parties Identification of the participant(s).
- Tender Data Formulation of the financial offer/breakdown and uploading of required documents.

Validation

- Financial Offer Preview Preview of the financial offer (not for Framework Contracts AUDIT 2018, EVENTS 2020 and EOM 2021, as the Financial Breakdown (Financial Offer) is uploaded in the previous Tender Data step).
- Pre-financing Request pre-financing and bank guarantee requirements (not applicable for public procurement procedures, nor for Framewor k Contract AUDIT 2018 as the pre-financing is always 0% for AUDIT Contracts).

You may view the steps within the tender procedure from the workflow graphic (1) situated at the top of the page. You can also click on a step in the

workflow to go directly to the step (if previously validated). The **position icon** 💙 indicates the **current step** selected.

Tip: After completing a step, remember to click on the "Save" button at the bottom of the page to save your data. You may also navigate between the steps of the tender process by using the "Next" and "Back" buttons, also at the bottom of the page.

In any step, you have access to the procedure information (2), submission details and submission documents (3), and submission deadline (4) from the two side boxes.

3.3.2 Prepare the Offer

3.3.2.1 Parties

Check the identification of the participant(s) in the tender submission for whether you are a sole submission or part of a consortium. If you are part of a consortium, the consortium structure will include information on the Consortium Leader and other members of the consortium, which is retrieved from the Framework Contract.

Please note that the *invitation to participate in the tender submission* is sent to <u>all</u> the Coordinator Contacts (**CoCos** or **PCoCos**) of the consortia. The **Consortium Leader** will coordinate with the Coordinator Contacts of the consortium, and nominate a Primary Coordinator Contact (**PCoCo**), who will submit the offer for the consortium. If a PCoCo has <u>not yet been nominated</u> for a consortium, the CoCo that initiates the submission procedure will automatically be designated as the PCoCo of the offer/tender for that consortium.

For more information on roles and permissions, please view User Roles and Permissions.

Once you have verified the information on the participants, click on the "Next" button at the bottom of the page to continue to the Tender Data step.

The information entered in the **Tender data** page will be used to generate your **Financial Offer** of the *tender submission*, and includes the **expertise and** fees of the Expert(s), required documents (*Curriculum Vitae* and *Statement of Availability and Exclusivity* of the Expert(s), etc.), and any other details and fee(s).

The type of information required is determined based on the *procedure type* (Specific Contract under Framework Contract – SIEA 2018, AUDIT 2018, PSF 2019, EVA 2020, EVENTS 2020 and EOM 2021), as well as the *payment modality* (Fee-based or Global Price).

Please note that for Framework Contracts AUDIT 2018, PSF 2019 (Lot 1 and 3) and EVA 2020, the payment modality is always Global Price, so only view the Global Price section below (if the case).

WARNING: For the Framework Contracts AUDIT 2018, EVENTS 2020 and EOM 2021 (Lot 1 and 2) – No Financial Offers will be generated in the Funding and Tenders Portal for the Request for Service, as the Financial Offer (Financial Breakdown) is uploaded directly to the system as a document in the Financial Breakdown tab (please view Document Upload below).

Fee-Based

· Fee(s) - Individual Expert per position

Individual expert and/or team is the description of the requirements for either the profile per expert, or expertise per category, or expertise common to all, or a mix of profile and expertise.

Fee(s) – Expertise by a team

Same as above, but for the whole expert team (i.e. not as per individual).

Lump Sum

A fee-based Specific Contract may include activities paid based on lump sums. The **Lump Sum** is an estimated *provisional amount*. Examples of lump sums are studies, evaluations, organisation of events such as conferences and training sessions. The contractor will <u>not</u> be able to exceed the amount foreseen.

Incidental Expenditure

Incidental expenditures will contain all the *reimbursables* (per diem, ticket flights, etc.). Incidental expenditures <u>must</u> be classified, and therefore defined by the object and quantity of the expenditure.

Expenditure Verification Provision

The **Expenditure Verification Provision** is determined when an *Expenditure Verification Report* is required (not required by default). If required, the amount that should be reserved for the report is disclosed by the European Commission and cannot be modified. The *Verification Report* fixed template will also be uploaded to the **Request for Service**.

Global Price

• Fee(s) - Individual Expert per position

Individual expert and/or team is the description of the requirements for either the profile per expert, or expertise per category, or expertise common to all, or a mix of profile and expertise.

Fee(s) – Expertise by a team

Same as above, but for the whole expert team (i.e. not as per individual).

For Framework Contract AUDIT 2018, EVENTS 2020 and EOM 2021 – Only the offer amount (total amount) is required. If taxes are to be charged to the Contracting Authority, then the total taxes amount must also be indicated (zero if exempt from taxes).

If you enter a total tender amount exceeding the maximum contract amount, then a **warning message** will be displayed, but it <u>will **not** block the</u> <u>submission process</u>.
