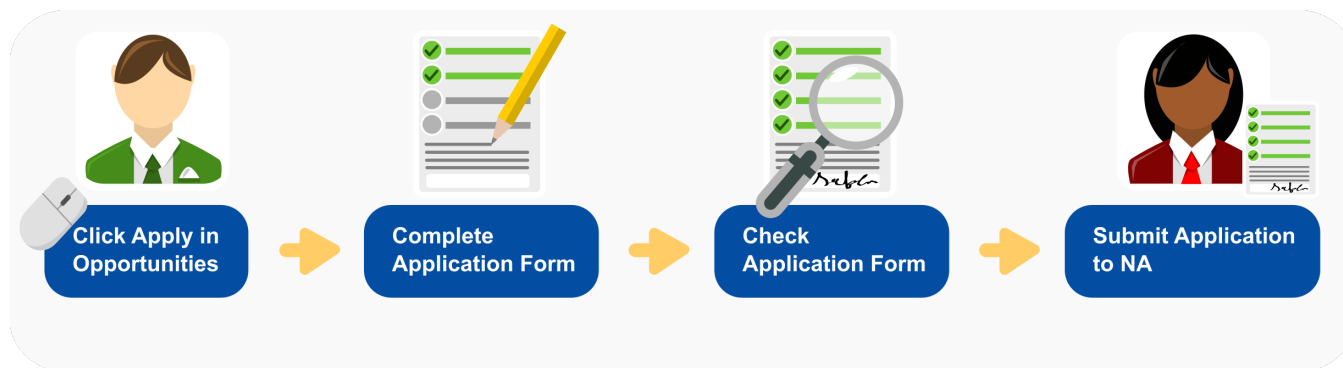

Please note that in order to successfully apply for an opportunity (call):

- the call must be open at the time of applying
- you must be logged in to EU Login with a registered profile
- the application must be submitted before the listed Deadline

Access "Opportunities" and select a programme (Erasmus+ or European Solidarity Corps)

 From calls for 2023 the Opportunities page has been updated to a new layout.

- **European Solidarity Corps** (3)

Click on one of the two options to view the opportunities available for that programme.

Each opportunity relates to a key action/field of either the Erasmus+ or the European Solidarity Corps programmes managed by National Agencies.



In the **Opportunities for Erasmus+** page you will see:

1. a number of filtering options, allowing you to filter and list only the opportunities that interest you
2. a list of all open/upcoming calls matching the selected filter options (if any)



Filtering on Erasmus+ opportunities

You can filter your content and see the details for an opportunity but you must log in to be able to apply.


The filter options can be hidden by clicking on the **left arrow (<)** next to **Filter by**.

6. Status bar
 - a. Green for open calls
 - b. Yellow for upcoming calls

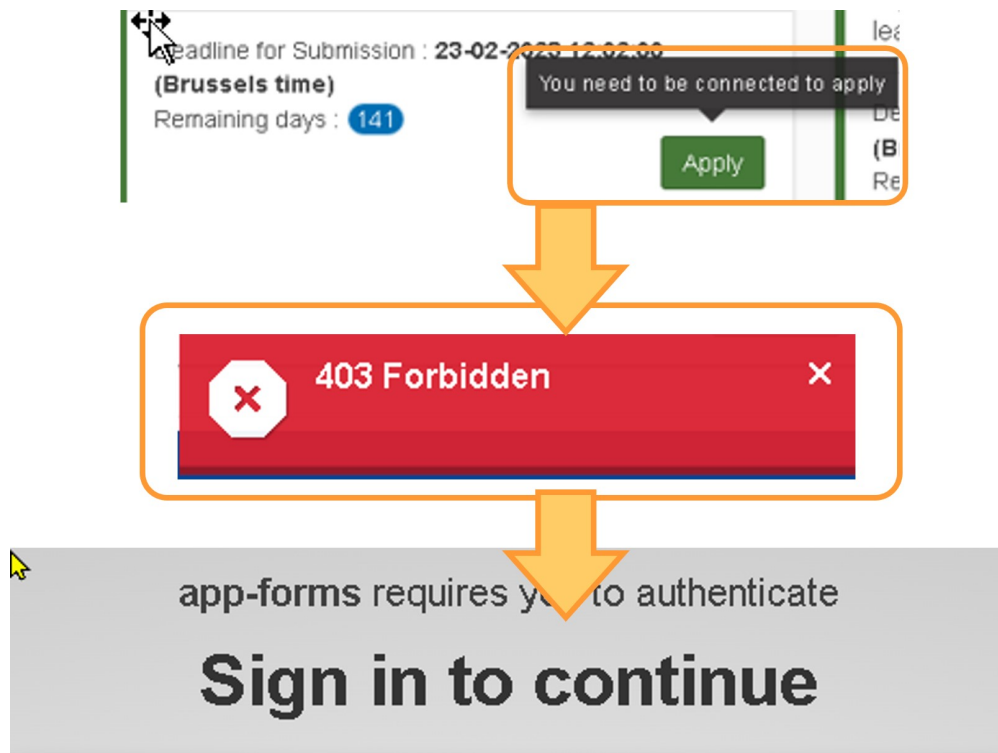

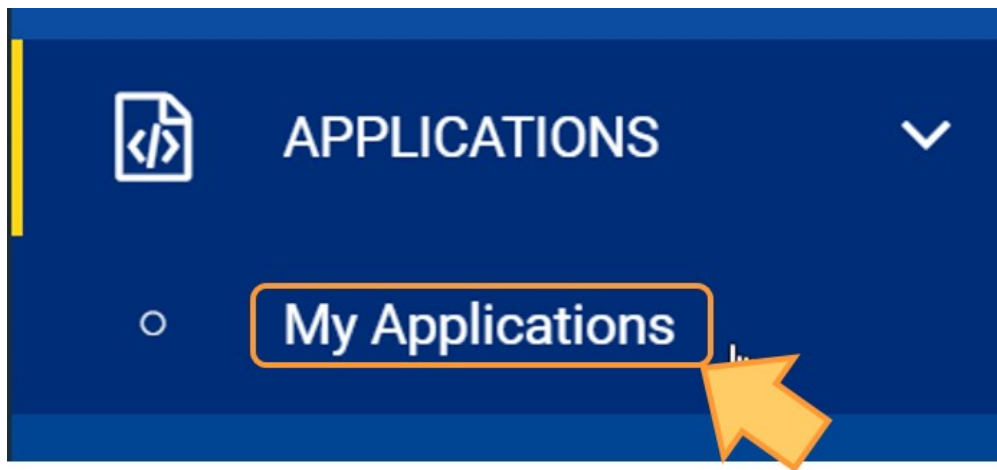
